ITEMS	LIMIT#	DESCRIPTION (Color, Size)
Batteries		Number limited to those needed to operate Portable Music Device or watch.
Blankets	2	State issue only .
Blush and Brush (makeup)	1 EA	No mirror. No metal.
Books/Magazines/Newspapers (excluding legal books)	8	Must come from publisher/dealer only. A total of eight (8) of these items in any combination are allowed. This includes religious books.
Bras	5	White or beige. Plain, sturdy design. No under-wire, push-ups, logos or padding. Can be a sports bra. Combination of state/personal. State will issue three (3).
Caps	1 EA	Note: Baseball Caps are not allowed. Offender Detail Caps: Issued by the Georgia Department of Corrections per SOP 401.01 are the only caps that will be allowed.
Cassette Tapes OR Compact Discs (NOT BOTH)	10	Pre-recorded with seal unbroken. No sexually explicit/violent lyrics. Head cleaner included in limit.

Cloth Headbands	2	White or beige color cloth. No wider than 2-inches. No logos, emblems, plastic or leather.
Coffee Mug	1	Unbreakable plastic; Shall not display any offensive language or offensive design.
Comb or Pick	1	Plastic, flexible comb less than 5" long.
Commissary Items		Consumable food and hygiene items, miscellaneous durable hygiene items.
Conditioner	2	Plastic bottle. Not to exceed 20 oz.
Curling Iron	1	Purchase through Commissary ONLY .
Dentures and Denture Cup	1 (Set)	Limit 1 plastic cup only.
Deodorant	2	Non-aerosol, non-flammable.
Disposable Razor	1	Personal or State issued. If State issued, must return used razor to receive another one.
Disposable Razor, personal	1 PK	Purchased through Commissary only
Drinking Cup	1	Unbreakable plastic; Shall not display any offensive language or offensive design.
Ear Plugs	1 PR	
Earrings	2 PR	Post or clip type.

Eye Liner	1	Black or brown only.
Eye Shadow	3	No orange, fluorescent or metallic colors. Limit three (3) or palette that holds four (4).
Eyeglasses	1 PR	Prescription or reading glasses from commissary
Fan	1	12", plastic blade, plastic safety grill, 6' cord.
Games	1	Checkers, Chess, Dominoes, puzzles, Scrabble, Monopoly (regulation on size). Must be small enough to fit inside locker. No tin.

Hair Brush	1	Plastic
Hair/Bobby Pins	1 PK	Purchased through Commissary only.
Hair Rollers	20	No electric curlers, plastic foam only, no wire.
Hair Styling Gel or Setting Lotion	2	Non-alcoholic, non-aerosol sprays.
Hairspray	2	Non-alcoholic, non-aerosol sprays.
Handkerchiefs	4	White, plain only.
Headphones for Portable Music Device or Media Device	2	Earbuds and/or earphones
Hose	2 PR	"Knee-high" type. "Natural" color only.
Housecoat/Robe	1	Cotton, fleece or terry cloth. No logos, initials, nylon, silk or satin. No blue or black. Solid colors only. No hoods, fabric belt OK, lightweight.
Knit Skull Cap/Toboggan	1	White or beige only. Knit pullover type. No ski mask.
Jacket	1	State issue only .
Legal, religious, Educational Materials		Must be able to fit neatly inside locker.
Letters	20	Can be stored in one 10" x 13" envelope.

Lipstick	1	No black, blue, green, orange, fluorescent or metallic colors.
Liquid Make-up	2	Plastic container only.
Lock(s)		State issued ONLY (where available; from commissary otherwise)
Lotion	2	Plastic containers. Not to exceed 20 oz.
Make-up Case	1	Clear, Plastic

Mirror	1	Unbreakable. Purchased from Offender Commissary.

Panties	8	White or beige. Eight (8) total (any combination of state or personal). Plain, full cut briefs. Cotton only. Panties may NOT be thong or string style.
Pants	3	State issue only .
Pencils and Pens	2 EA	Pens: clip-type, non-retractable.
Pencils (Coloring)	1 pack	
Perfume	1	Creme or lotion only. Plastic container. 5 oz. only.
Photographs	100	20 loose photos, 80 in album
Picture Album	1	Plastic binder, absolutely no metal. No larger than 10"x12"
Pillow Cases	2	State issue only .
Plastic Bowl and Lid	1	Small
Plastic Spoon or spork	1	
Playing Cards	2	Factory sealed.
Pocket Dictionary	1	
Pony Tail Holders	5	Solid Color Only , no large bows, no metal, no sequins, no beads, no rubber bands
Prayer Rug	1	
Pressed Powder (makeup)	1	No loose powder. No mirror.
Portable Music Device (Radio/Tape Player OR Radio/CD Player (NOT BOTH) and/or JP4 Player or Media Device with Headphones	1	Combination radio/cassette player OR CD player, size dictated by vendor; no external speaker, no recording ability, belt clip and charger is allowed.
Rain Coat	1	Yellow in color. State issue only
Religious Medallion/Pendant with Necklace	1	Not homemade; recognized religion by chaplain; chain may not be worn without pendant. Pendant cannot exceed 1" x 1" in size. Chain cannot exceed 18" in length or 1/4" in. width.
Ring	1	A wedding set is considered one (1) ring.
Sanitary Napkins	36 EA or as needed	Combination of state and personal.
Scarf or Hajib	1	Square headscarf – 24". Regular scarf worn in dorm only. Hajib may be worn as necessary unless otherwise directed by administration. No blue or black.
Shampoo	2	Plastic bottle. Not to exceed 20 oz.
Sheets	2	State issue only
Shirts, short sleeve	3	State issue only

Shoes, Bedroom	1 PR	Plain, solid colors only. Flat-smooth bottoms. No black or blue. No characters, big fuzzies or men shoes.
Shoes, Dress	1 PR	T.C. Only

Shoes, Clogs	1 PR	State issue only
Shoes, Shower	1 PR	
Shoes, Tennis	1 PR	Value < \$75.00 retail; solid black or white only, insignia must be same color; no cavities, inserts, heel pads, gel pads, air cushions, air pumps, or other spaces in which Contraband can be carried)
Shower Cap	1	Clear plastic.
Soap	2	Personal or state
Socks	5 PR	White only. Ankle or crew type. No emblems or nylon.
Stamps, Postage	20 STAMPS	Purchased in Offender Commissary only.
Sweatshirts	2	White or gray only. Plain. No logos, hoods or zippers.
Tampons	24 EA or as needed	Combination of state and personal
Thermal Underwear	2 PR	Plain, white or light gray. No lace or "V" neck shirts. No oversized.
Toboggan	1	Optional for State to issue.
Tooth Brush	1

Towels	4	White or beige in color. Limit four (4) (state issue/personal). No larger than 30" x 52".
Tweezers	1	Blunt tip, small. Commissary only where allowed.
Undershirts	4	White in color / limit four (4). State will issue two (2). No dark colors such as black or blue allowed. Short sleeve-crew neck style. No pockets or "V" neck. No oversized.
Wash Cloths	2	White or beige only. 12" x 12".
Watchband (Replacement)	1	
Wristwatch	1	Total value of all jewelry less than \$250.00 with all jewelry. If not \$200.00 limit on value.
Writing Paper	2 Pads	No wire. 100 sheets – maximum, per tablet.
Writing Paper-Other (drawing pad, carbon, etc.)	1 pad/pack
