Registration Renewals

Renewing your Vehicle, Boat, or Mobile Home Registration?
Registration renewals can be processed 90 days in advance.

Option #1

Visit taxcollector.com to Renew Online with RenewExpress!

To renew your registration online with RenewExpress, you will need one of the following:

- The PIN # on your renewal notice (located in the upper left corner of the notice, beneath your registration expiration date)
Your date of birth and the Florida license plate number, boat decal number, or mobile home decal number

Credit cards are accepted online! Credit and debit card payments are subject to a processing fee of \$2.95 per registration renewal (the Manatee County Tax Collector does not receive any portion of the processing fee).

Current, valid Florida insurance must be on file with the Department of Highway Safety and Motor Vehicles. If you receive an "insurance not on file" message when attempting to renew online, please contact your insurance company directly.

Note: Proof of insurance is not required to be on file in order to renew a boat, trailer, mobile home, and/or motorcycle registration.

Option #2

Visit the First Manatee South County Tag Agency!

The First Manatee South County Tag Agency, located at 5756 14th Street W Bradenton, FL 34207, is a privately owned business operating under the authority granted by the Manatee County Tax Collector's office; which processes vehicle, boat, and mobile home registration and title transactions. With extended hours (9AM – 6PM, Monday – Friday) and Saturday hours (9AM – 2PM), this office may be a more convenient option for your busy schedule.

Note: This office accepts cash and check only. A 2% fee will be charged on all check transactions to guarantee funds.

Option #3

Renew by Mail

- Visit taxcollector.com to access the Application for Renewal by Mail on the Motor Vehicle Forms page.
Complete the form and mail it to the address listed on the bottom of the form.
If you have multiple renewals, complete a separate form for each renewal.
Acceptable payment can be made by check or money order.

Registration Renewals

Option #4

Renew in Person

Only Manatee County residents can renew their registration in person at the Manatee County Tax Collector's Office.

Out-of-County residents must visit First Manatee South County Tag Agency (or another county) in order to renew their registration in person. Refer to Option #2 on the first page for office location and information.

The following items are required when renewing **in person**:

- A valid US Driver License/ID Card. We will also accept a valid U.S. or foreign passport, or Canadian DL/ID.
- Your renewal notice or previous registration certificate will help **expedite** the renewal process.
 - If unable to produce these documents, you must be able to recite the vehicle, boat, and/or mobile home details (year, make, color, etc.).
 - If renewing on behalf of someone else, you must provide the vehicle owner's name, address, and vehicle details.
- Current, valid **Florida** insurance may be required and it is recommended that you bring it in when coming to our office. The 5-digit Florida Insurance Company Code must be listed and the VIN on the vehicle must match the VIN listed on your valid insurance document.
 - If the 5-digit Florida Insurance Company Code is missing or the VIN does not match, please contact your insurance company directly for a corrected insurance card.

Note: Proof of insurance is not required to be submitted to our office for boat, trailer, mobile home, and/or motorcycle registrations.
