Driving Transcripts

ANY service, including general information, provided by our Driver License Office is subject to \$6.25 at the beginning of the visit. Additional transaction fees may apply.

Not a Manatee County resident? Out-of-County residents can only be served at our Driver License Office, located at 904 301 Blvd W, Bradenton. An appointment is required. Visit taxcollector.com to schedule an appointment. You must select the “Non-Manatee County Resident DL/ID Card Transaction” Service in order to be served. Testing services (e.g. road testing, written exams) are provided for Manatee County residents only.

A driving transcript provides details about your driving history, including various violations, suspensions, restrictions and other information pertinent to your Florida driving record. There are **three types** of transcripts that may be printed and purchased for your Florida driving record. (Driving transcripts cannot be purchased on behalf of other drivers.)

- 3-Year Record.....\$14.25...Uncertified
- 7-Year Record.....\$16.25...Uncertified
- Complete Record.....\$16.25...Uncertified

Sales of driving transcripts are final and will not be voided for any reason.

At this time, driving transcripts do not indicate the current status of your Florida driver license. If interested in knowing the **current status** of your Florida driver license, you must access <https://services.flhsmv.gov/DLCheck/> and inquire on your Florida driver license number. This website will advise you of any outstanding suspensions and the process for reinstating your driving privilege.

Note: **Certified driving transcripts** must be purchased at the Manatee County Clerk of Circuit Court. You may contact their office at 941.749.1800 or visit manateeclerk.com/ for more information.

How to Interpret a Driving Transcript

The top portion of the transcript details your personal and driver license information (driver license or identification card issuances, exams passed, and driver education information).

The information contained within the middle portion of the transcript details the following:

- Department approved correspondences
- Crash entries (including the date/place the crash occurred and important details involving the crash)
- Guilty convictions for traffic violations or with adjudication withheld (including the date the issued, the ticket number, and if points were assessed with the ticket)
- All open or cleared suspensions, revocations, cancellations, disqualifications of the driving privilege (unless retention is met and the entry has been purged)

Point Suspensions

Point suspensions are generated when excessive points are accumulated within the following time periods:

- 12 points within a 12-month period = 30 days suspension
- 18 points within a 18-month period = 3 months suspension
- 24 points within a 36-month period = 1 year suspension

Note: Points are not added to your driving record until your citation(s) have been paid.
