# Non-US Citizen (Canadian Citizen)

**ANY service, including general information, provided by our Driver License Office is subject to \$6.25 at the beginning of the visit. Additional transaction fees may apply.**

**Not a Manatee County resident?** Out-of-County residents can only be served at our [Driver License Office](#), located at 904 301 Blvd W, Bradenton. An appointment is required. Visit [taxcollector.com](http://taxcollector.com) to schedule an appointment. You must select the “Non-Manatee County Resident DL/ID Card Transaction” Service in order to be served. Testing services (e.g. road testing, written exams) are provided for Manatee County residents only.

- An appointment will be required to complete your transaction.** Visit [taxcollector.com](http://taxcollector.com) to schedule an appointment.
- You must present one of the following original Canadian Citizen documents every time you apply for a license or ID card. In addition to one of the following documents, **you must present another document that has your name on it**, such as a Florida or out-of-state license, military ID, vehicle registration, voter card, Social Security Card, etc.
  - Canadian Birth Certificate
  - Valid Canadian Passport
  - Canadian Naturalization Certificate
  - Canadian Certificate of Citizenship

Note: Anytime you legally change your name due to marriage or court order, your name must first be changed on your Canadian citizenship document before you can apply for a name change on your Florida license or ID card. You would be required to show your Canadian citizenship document in your new name at that time. Proof to tie/link your new name to the name on the license you are presenting may be required.

- You must also show **proof of Social Security #** (e.g. Social Security Card), if applicable. This proof is only required to be submitted one time after January 1, 2010 in order to be issued a Real ID compliant Florida license or ID card.

Note: If you are later issued a Social Security Number, you will need to provide proof to us at that time in order to update your record.

- You must also provide us with **2 proofs of residential address in your name** (e.g. utility bill, bank statement, car registration, voter registration, cell phone bill, etc.). This proof is only required to be submitted one time after January 1, 2010 in order to be issued a Real ID compliant Florida license or ID card.

**Exception:** If you change your residential address after being issued a Real ID compliant license or ID card, you will need to provide two new proofs at that time to update the address on your license or ID card.

# Non-US Citizen (Canadian Citizen)

- As a Canadian citizen, you have the following two options when it comes to reciprocating your driving privileges. This does not apply if you are applying for a Florida ID card.

## #1 Surrender Current Canadian License

- All driving privileges will be reciprocated
- No testing will be required
- Take Vision and Hearing exam

## #2 Keep Canadian License or It's Expired

- No exams will be reciprocated
- Take General Knowledge written exam\*\*
- Take Driving Skills Road Test\*\*
- Take Vision and Hearing exam

Note: If you choose this option and do not pass an exam/test, you cannot later choose option #1.

**\*\*Written exam and Driving Skills Road Test administered by appointment only for Manatee County residents.**

**Private companies** can administer the Driving Skills Road Test on **weekends, after hours**, or during regular business hours. Upon successful completion of the test, the company uploads your results to the State of Florida, allowing us to use the test results on file. This expedites the issuance of your license when you visit our office. **Contact Ault's Driver Education Center at 941.355.4202 or by email at [aults@verizon.net](mailto:aults@verizon.net), or All Florida Safety Institute LLC at 866.838.0055** for details. You can also visit <https://www.flhsmv.gov/driver-licenses-id-cards/driver-license-exams/> for a list of other private providers.

- Your license or ID card will be valid for 1 year.
- The fee ranges from \$31.25 to \$81.25 plus \$7.00 for each endorsement.
- If we are unable to verify your lawful status and secondary verification is required, your Florida license or ID card *may* be **mailed from Tallahassee** within 60 days. If you applied for a Florida license, you will be given a temporary driving permit to allow you to drive in the meantime. *If you applied for a Florida ID, you will not be given a temporary ID.*
