# Non-US Citizen (Non-Immigrant)

**ANY service, including general information, provided by our Driver License Office is subject to \$6.25 at the beginning of the visit. Additional transaction fees may apply.**

**Not a Manatee County resident?** Out-of-County residents can only be served at our [Driver License Office](#), located at 904 301 Blvd W, Bradenton. An appointment is required. Visit [taxcollector.com](http://taxcollector.com) to schedule an appointment. You must select the “Non-Manatee County Resident DL/ID Card Transaction” Service in order to be served. Testing services (e.g. road testing, written exams) are provided for Manatee County residents only.

- An appointment will be required to complete your transaction.** Visit [taxcollector.com](http://taxcollector.com) to schedule an appointment.
  
- You must present original legal presence documents issued by the US Citizenship and Immigration Services ([USCIS](#)) every time you apply for a license or ID card in the State of Florida. The documents **must have at least 61 days remaining** until the expiration date. These documents prove that you have been granted permission to lawfully reside in the US.

Note: Anytime you legally change your name due to marriage or court order, your name must first be changed with USCIS before you can apply for a name change on your Florida license or ID card. You will still be required to present your original name change document (e.g. marriage license, court order) and your new name must verify in the State of Florida system.

- You must also show **proof of Social Security #** (e.g. Social Security Card), if applicable. This proof is only required to be submitted one time after January 1, 2010 in order to be issued a Real ID compliant Florida license or ID card. If you don't have a Social Security #, you must also submit secondary identification.

Note: If you are later issued a Social Security Number, you will need to provide proof to us at that time in order to update your record.

- You must also provide us with **2 proofs of residential address in your name** (e.g. utility bill, bank statement, car registration, voter registration, cell phone bill, etc.). This proof is only required to be submitted one time after January 1, 2010 in order to be issued a Real ID compliant Florida license or ID card.

**Exception:** If you change your residential address after being issued a Real ID compliant license or ID card, you will need to provide two new proofs at that time to update the address on your license or ID card.

# Non-US Citizen (Non-Immigrant)

- If you have an out-of-country license or have never been licensed before, you must complete the following exams. (If you already have a Florida or out-of-state license, the written exams and the Driving Skills Road Test will be reciprocated.) This does not apply if you are applying for a Florida ID card.

### Out-of-Country Licenses

- General Knowledge [written exam](#)\*\* (except France, S Korea & Taiwan)
- [Driving Skills Road Test](#)\*\* (except France, Germany, S Korea & Taiwan)
- Vision and Hearing exam

### Never Licensed Before

- Traffic Law & Substance Abuse (TLSAE)
- General Knowledge [written exam](#)\*\*
- [Driving Skills Road Test](#)\*\*
- Vision and Hearing exam

**\*\*Written exam and Driving Skills Road Test administered by appointment only for Manatee County residents.**

**Private companies** can administer the Driving Skills Road Test on **weekends, after hours**, or during regular business hours. Upon successful completion of the test, the company uploads your results to the State of Florida, allowing us to use the test results on file. This expedites the issuance of your license when you visit our office. **Contact Ault’s Driver Education Center at 941.355.4202 or by email at [aults@verizon.net](mailto:aults@verizon.net), or All Florida Safety Institute LLC at 866.838.0055** for details. - Your license or ID card will be valid until the expiration date of your USCIS documentation not to exceed 4 years.
- The fee ranges from \$31.25 to \$81.25 plus \$7.00 for each endorsement.
- If we are unable to verify your lawful status and secondary verification is required, your Florida license or ID card *may* be **mailed from Tallahassee** within 60 days. If you applied for a Florida license, you will be given a temporary driving permit to allow you to drive in the meantime. *If you applied for a Florida ID, you will not be given a temporary ID.*
