**AUTHORITY**

**DEFINITION**

The Office of Motor Vehicles will authorize a Driver Rehabilitation Specialist to issue a Temporary "Class E" Medical Assessment Driving Permit for the purpose of driver assessment and training to an individual who is not licensed to drive or who has an expired license provided the license is not under suspension or revocation.

**REQUIREMENTS**

Prior to conducting any driver assessments or training, any individual who wishes to act as a Driver Rehabilitation Specialist in relation to this department, must first submit satisfactory proof of his qualifications to the Assistant Secretary or his designee for approval.

- The Driver Rehabilitation Specialist shall contact the Office of Motor Vehicles, CDL Helpdesk Unit, at (225) 925-3929, to verify the driving status of each individual before issuing a permit. The driving privileges cannot be suspended or revoked for anything other than a medical or physical condition for this permit to be utilized. The individual must reinstate all other suspensions or revocations prior to the issuance of the permit.
- The permit is valid only if signed by the applicant and by the Driver Rehabilitation Specialist and remains valid only during the individual's participation in an actual in-car evaluation when the designated specialist is present.
- The permit shall only be issued for a period of six weeks, to begin on the first date of the evaluation, which must be indicated on the permit.
- The temporary permit shall only be issued to individuals age seventeen or older. If the individual is not yet eighteen, the permit must be signed by the custodial parent or legal guardian authorizing the permit.
